Becky Covington-Kaiser, landowner, realtor, and previous Chair of committee, spoke on keeping the committee intact and her opinion that it's valuable to the citizens of the county, county staff and the Supervisors. An objection letter from Barbara Fields, previous committee member, was read into the record by Executive Officer Knox. Commissioners Zaragoza and Ayon had question for Ms. Covington-Kaiser regarding the any steps made to approach Board of Supervisors and participation to resume committee. Commissioners Fowler and Albright made comments in support of keeping the committee. Commissioners Scrivner and Parlier made comments in support of the recent efforts by the City of Bakersfield and the County to provide inform effected residents and provide a transparent process. Couch and Scrivner both asked Attorney Tom Schroeder regarding conflict with voting on this matter both at LAFCo and at the Board of Supervisors. Tom answered that there is no conflict on the LAFCo side but encouraged them to look to County Counsel for guidance on any voting that takes place on the Board of Supervisors side. Commissioner Fowler made a motion to send a letter from the Commission to the Board of Supervisors recommending that they keep and not dissolve the Citizens Advisory Committee on Annexations.
